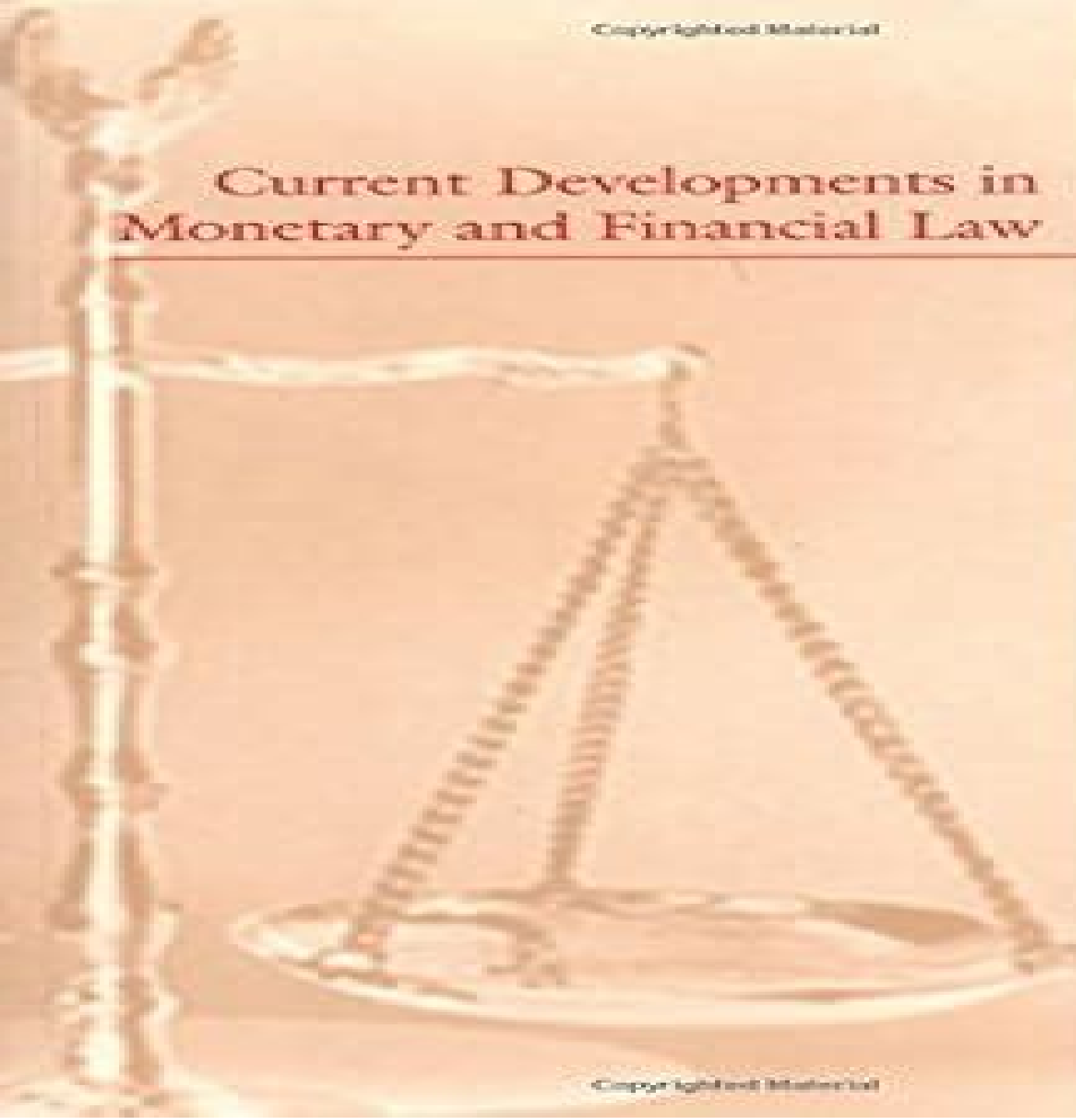

It then examines the complex phenomenon of exchange rate misalignment under international monetary and trade law and the increasing regionalization of monetary sovereignty notably in light of the European sovereign debt crisis. Finally it assesses the role the concept of monetary sovereignty can play in the reorganization of international finance following the recent global financial crisis.
