El intérprete judicial: ese interlocutor emocional entre el acusado y el juez.

El intérprete es la persona que da forma a las ideas y deseos del otro. Una especie de actor que ha de interpretar el papel de una persona que puede ser privada de libertad durante muchos años. De ahí la importancia que tiene conocer el verdadero significado de una cosa o equivocarlo. Interpretar correctamente un gesto o desfigurarlo, trasmitir o cambiar su sentido, y saber dar o no el correcto significado a las palabras, actitudes, y gestos del acusado. Traducir palabras es traducir culturas.

No sé si como consecuencia de la globalización, de los problemas que plantea el crimen organizado o, tal vez, de la pobreza, lo cierto es que los intermediarios lingüísticos se han convertido en una pieza clave del sistema judicial español. En traductores e intérpretes recae una responsabilidad del Estado. Todo un colectivo de personas que desconoce la lengua del país en el que hoy viven precisan de este interlocutor en el ámbito no sólo policial y judicial sino también en otras actuaciones procesales no reguladas en la ley, como en las entrevistas con los abogados, ciertos interrogatorios por parte de los agentes del orden para decidir si tienen derecho a ciertos derechos, como el de asilo político, traducción de documentos de naturaleza muy variada y otras actuaciones no reguladas.

Tenemos que partir de una premisa básica para comprender lo que está sucediendo en el estado español en el momento actual como fruto de un déficit democrático que arrastramos desde hace años. En nuestro país, la Licenciatura de Traducción e Interpretación se creó en 1991. Estamos hablando de una carrera relativamente reciente y desconocida. Y este desconocimiento es lo que hace creer a muchos que la persona que habla una lengua está facultada para actuar como traductor e intérprete en los tribunales de justicia. La situación es tan grave que, frente a las recomendaciones incluidas en el Libro Verde de la Comisión Europea, la Ley Orgánica del Poder Judicial en el art. 231,5 recientemente aprobado dispone que: "En las actuaciones orales, el juez o tribunal podrá habilitar como intérprete a cualquier persona conocedora de la lengua empleada, previo juramento o promesa de aquélla".

Pero un precepto de nuestra ley procesal mucho más antiguo cuando habla de los testigos dice que: "El intérprete será elegido entre los que tengan título de tales, si lo hubiere en el pueblo. En su defecto será nombrado un maestro del correspondiente idioma y, sin tampoco lo hubiere cualquier persona que lo sepa". Estaba pensado para una España rural, para una realidad como la de 1882, y como una garantía prevista sólo para los testigos. Es un precepto que sigue vigente y que nos
