Direct supervision - ANSWER-Requires the physical presence of the licensed PT for consultation and direction of the actions of a PT or PTA who is practicing under a temporary permit and who is a candidate for licensure by examination.

Physical therapy assessment - ANSWER-Observational, verbal, or manual determinations of the function of the musculoskeletal or neuromuscular system relative to physical therapy, including, but not limited to, rang of motion of a joint, motor power, postural attitudes, biomechanical function, locomotion, or functional abilities, for the purpose of making recommendations for treatment.
