Later, Shaw searches Howdy's home and finds him there holding some of the stolen items. Both Howdy and Nobel move to suppress the evidence found in their homes. What results?

Nobel wins and Howdy loses. Nobel wins because Shaw had an arrest warrant only for Howdy. That arrest warrant provided Shaw with no added authority to search the home of a third party like Nobel. Absent a warrant, exigent circumstances, or consent, Shaw could not search Nobel's home even if he knew the drugs were there.
