French Women and the Empire Marie-Paule Ha, 2014-05-08 French Women and the Empire is the first book length investigation of colonial gender politics in Third Republic France using Indochina as a case study Its departure point is the interrogation of the dramatic change in the French colonialist view of the empire as an exclusively male preserve where women feared to tread At the turn of the century a reverse discourse emerged in the metropole forcefully arguing that colonial female emigration was essential to true colonisation.
