The immense foreign demand has been fueled by the secular expansion of the global economy It has been shaped by the pressing need in emerging markets to develop an educated workforce The great chasm creates an opportunity for American academic institutions to extend their global reach Bridging the gap however is not an easy feat for most U S colleges and universities It is complicated by an institutional culture that is averse to commercialization an organizational structure that is operationally slow and a governance system that often leads to indecision conflict and paralysis Bridging the gap requires fundamental changes in the culture organization and governance of traditional U S academic institutions These changes will pave the way for international expansion which could enhance the financial well being of these institutions the social well being of less developed nations and the critical role that America plays globally in knowledge creation the dissemination of ideas and the pursuit of the truth
