addresses risk and resilience in the interactions between children and families and the various systems with which they interact e.g. child welfare. It is no secret that the United States continues to be the leading nation for the incarceration of men and women and this large prison population includes approximately 120,000 incarcerated mothers and 1.1 million incarcerated fathers. Incarceration of a parent is recognized as an adverse childhood experience, an acute or chronic situation that for most people is stressful and potentially traumatic. Children of incarcerated parents may experience other adverse childhood experiences such as poverty, homelessness, parental substance abuse and other mental health problems and family violence. The chapters in this book document some of the challenges as well as some promising ways that can help parents and families begin to meet these challenges.
