system infused with English ideas interests and institutions In countries like Japan and Argentina where nationalist concerns focused on infant industry protection and the growth of military power the gold standard enabled the expansion of trade and the goals of the age industry and empire Bryan argues that these countries looked less to Britain and more to North America and the rest of Europe for ideological models Not only does this history challenge our idealistic notions of the prewar period but it also reorients our understanding of the history that followed Policymakers of the 1920s latched onto the idea that global prosperity before World War I was the result of a system dominated by English liberalism Their attempt to reproduce this triumph helped bring about the global downturn the Great Depression and the collapse of the interwar world
