Schon beim ersten Zuspätkommen des Kollegen spricht er das Thema an: „Guten Morgen, Markus. Du kommst zu spät zum Meeting. Mir ist es sehr wichtig, dass alle pünktlich erscheinen. Sei beim nächsten Mal bitte rechtzeitig da“.

Kommt der Mitarbeiter dennoch wieder zu spät wird, wird der Vertriebsleiter im Tonfall bestimmter und einen Tick deutlicher. Wie auf eine Klimax zusteuern wird der Tonfall bei jedem Zuspätkommen rauer. Kommt der Mitarbeiter wieder zu spät, weiß er intuitiv, dass ihm (weiterer) Ärger droht.
