## II. OFFER

### a. What is an offer?

"An expression of willingness to contract on specified terms, made with the intention that it shall become binding as soon as it is accepted by the person to whom it is addressed" E. Peel, *Treitel on the Law of Contract*, 14<sup>th</sup> edition

### b. Offer v Invitation to treat

Offer ≠ invitation

An invitation is an indication that a person is willing to enter 'negotiations' but that he is not willing to be bound by the terms mentioned.

### c. Advertisements

(a) **General rule:** advertisement of good = invitation to treat → e.g.: in *Partridge v Grittenden* [1968] 2 ALL ER 421 it was held that as a legal proposition it has to be backed by an authority

(b) **Exception:** see, e.g. *Lefowitz v Great Minneapolis Surplus Store* (1957) 86 NW 2d 689 or *Carlill v Carbolic Smoke Ball Co* [1893] 1 QB 256

### d. Display of goods

(a) **General rule:** display of goods = invitation to treat → e.g., *Pharmaceutical Society v Boots* [1953] 1 QB

(b) **Exception:** depending on the circumstances, words used, etc.
