The income from a sole proprietorship is netted with related ordinary and necessary business expenses to determine the effect on AGI. Expenses for employees would be Miscellaneous Itemized Deductions subject to the 2% of AGI limit; expenses for self-employed taxpayers would be *for* AGI deductions.
