The chapters in this volume show that Donald Trump's grip on the Republican Party is a symptom and a catalyst but not the cause of the contemporary contestations of the liberal script in the US. To discern their major drivers from a longue durée perspective, each chapter takes a step back and asks three main questions: 1. How can we best describe the current contestations of the liberal script in the US, exploring the extent to which the US is unique in comparison to other liberal democracies facing similar contestations? 2.
