

Face-to-Face Encounter Form Guidelines

All sections of the Face-to-Face Encounter Form must be complete. Physician support staff, such as nurse or social worker, can fill in the form based on the documentation in the patient's clinical record:

Face-to-Face Encounter Date:

- Write in the date the face-to-face encounter occurred (90 days prior to or 30 days after start of home health services)
 - If a date is on the form and is incorrect, draw a line through it, and write in the correct date of the encounter and initial.

Face-to-Face Encounter Performed By:

- Write in the name of the physician or non-physician practitioner (Nurse Practitioner, Clinical Nurse Specialist, or Physician Assistant) who actually performed the face-to-face encounter

The face-to-face encounter was related to the medical condition. Examples:

- State the medical condition that is the primary reason for home health care: CHF, CAD, COPD, CVA, MI, CABG, Diabetes, Arthroplasty, Cancer, Dysphagia, Neurological Disorder, Anticoagulation Dosing, Fractures, Spinal Fusion, Knee/ Hip Replacement, Laminectomy, Ostomy, Surgery, Wound Care, IV Therapy, Enteral Tube Feeds

I certify...the following are medically necessary home health services:

Check all that apply. (The disciplines listed are those disciplines that qualify as a skilled service for home health care. Other disciplines may be ordered with referral, but are not included on this form).

To provide ... care/treatments:

- Physicians signing the plan of care do not have to complete this section.

Physicians who certify patients as eligible for home health services are required to include an explanation of how the clinical findings of the face-to-face encounter support that the patient is homebound: (examples below)

- Absences from the home require considerable & taxing effort
- Absences from the home are infrequent or of short duration, for medical reasons or religious services
- Medical restrictions; infection, compromised immune status
- Does not apply for Medicare patients

Physicians who certify patients as eligible for home health services are required to include an explanation of how the clinical findings of the face-to-face encounter support the patient's need for intermittent skilled nursing and/or therapy services:

- Write details of the encounter that support the need for the services ordered, for example:
 - Condition requires nursing skilled assessment and interventions, skilled teaching and assessment; Direct skilled care: wounds, ostomies, catheter changes and maintenance, medication administration-injections/IVs, tube feedings, drain management and teaching
 - Condition requires skilled therapy for assessment, gait training, therapeutic exercises, post-operative joint care and teaching

Physician signature required (only the physician can sign and date, no stamps)

Date of Signature (hand written date, no stamps)
