	Use privacy impact assessments to identify deployments and applications that present higher risks to privacy.		Restrict access to data. Clearly define rules stating who has access and when and for what purpose access may be granted.
	Minimize data collection by gathering only the necessary information for the intended purpose.		Embrace the concept of proportionality by offering stakeholders fair and explicit privacy options when they agree to use a product or service.
	Store data for only as long as is reasonably necessary or required by law or regulation.		Support reciprocity by giving data subjects control over their privacy preferences as much as possible. Such privacy controls should be easy to use, and privacy should be the default, not an option.
	Take reasonable steps to ensure that personal data is accurate. Offer data subjects the opportunity to correct errors.		Be transparent in presenting privacy options, practices and settings. Explain in plain language how and why personal data is being collected, used, shared, retained and disposed of.
	Implement appropriate policies and procedures to process and store data in a secure manner.		Conduct regular reviews and audits to ensure compliance with legal and regulatory requirements and industry standards and best practices.
